Dear Chairman Reed and Ranking Member Murkowski:

We wish to extend our thanks and appreciation to you for your work on the FY12 Interior Appropriations bill and ask for your continued support for the Land and Water Conservation Fund (LWCF) and specifically, the State Assistance program of the LWCF as you consider funding for FY13.

Once again, it is imperative that you provide funding for the State Assistance program. We specifically ask you to allocate 40 percent of total LWCF funding to the State Assistance program, the same amount that is provided to the federal land acquisition program and ask you to take steps to ensure the State Assistance funds are distributed to the states and localities using the same formula that has been successful from FYs 1965-2011- a formula which does not include a competitive grant program administered by the Department of Interior (DOI).

As you may recall, the LWCF is budget neutral. The authors of the original legislation determined that revenues raised from the sale of oil and gas leases would be the perfect source of funds for reinvestment toward the conservation and protection of our nation's outdoor recreation areas at the state and local level. As a result, throughout its forty-six year history, the LWCF State Assistance program has provided critical funds in 98% of the counties across America. Funds are distributed to every state in the nation on a formula basis which recognizes the individual needs of rural and urban areas. States then award grants to projects within their borders based on the needs identified by the states.

There is a misconception that LWCF is only a federal land acquisition program. That is not true as local communities receive significant benefit from the program through grants for capital construction and improvement projects for outdoor recreational resources such as playgrounds and recreation areas. The LWCF State Assistance program fosters economic growth through support of active outdoor recreation, which contributes \$730 billion annually to the U.S. economy and supports 6.5 million American jobs according to research done by the Outdoor Industry Association. Another study by the University of Massachusetts notes that investment in park and recreation conservation projects, such as those supported by the LWCF State Assistance program, creates jobs at an even higher rate than sectors such as new highway construction, oil, gas, and solar energy projects. LWCF State Assistance grants are also leveraged dollar for dollar and more through a required non-federal match.

Once again, for FY13, the DOI has proposed changing the distribution formula of the program; specifically proposing to use a significant portion of State Assistance funds for a DOI administered competitive grant program. Such an idea would effectively decrease the amount of funding to each state through the current formula and reduce the number of local projects that are constructed annually.

We fully recognize that the country is in an economic crisis and program reductions and eliminations must be implemented in order to salvage our nation's financial security. However, at a time when the states are facing \$18.5 billion in unmet outdoor recreational needs, funding for the State Assistance program is even more critical.

The organizations and members signed below are asking you to strengthen the investment in states and local communities by allocating a minimum of 40% of the total LWCF funding to the State Assistance program in the FY13 Interior Appropriations bill. We applaud the decision you made in FY12 to not fund a DOI administered competitive grant program, and we ask you to again specify, in the language of the bill, that for FY 13, zero State Assistance dollars are to be used for the DOI competitive grant program.

Thank you for supporting a program that benefits your constituents and all of those across the U.S.
